1 I, ROSS D. MURRAY, declare and state as follows:

2 1. I am employed as a Vice President of Securities by Gilardi & Co. LLC  
3 (“Gilardi”), located at 1 McInnis Parkway, Suite 250, San Rafael, California.  
4 Pursuant to this Court’s October 14, 2021 Order Preliminarily Approving Settlement  
5 and Providing for Notice (“Notice Order”), Gilardi was appointed to supervise and  
6 administer the notice procedure as well as the processing of claims in connection  
7 with the proposed Settlement of the above-captioned litigation (the “Litigation”). I  
8 oversaw the notice services that Gilardi provided in accordance with the Notice  
9 Order.

10 2. I submit this declaration as a supplement to my earlier declaration, the  
11 Declaration of Ross D. Murray Regarding Notice Dissemination, Publication, and  
12 Requests for Exclusion Received to Date (the “Initial Mailing Declaration”) (ECF  
13 No. 206). The following statements are based on my personal knowledge and  
14 information provided to me by other Gilardi employees and if called to testify I could  
15 and would do so competently.

16 **UPDATE ON DISSEMINATION OF THE CLAIM PACKAGE**

17 3. As more fully detailed in the Initial Mailing Declaration, as of  
18 December 17, 2021, Gilardi had mailed 84,600 copies of the Court-approved Notice  
19 of Pendency and Settlement of Class Action (the “Notice”) and Proof of Claim and  
20 Release form (the “Proof of Claim”) (collectively, the “Claim Package”) to potential  
21 Class Members and their nominees. *See* Initial Mailing Declaration, ¶11.

22 4. Since December 17, 2021, Gilardi has mailed an additional 322 copies  
23 of the Claim Package in response to requests from potential Class Members, brokers,  
24 and nominees and as a result of mail returned as undeliverable for which new  
25 addresses were identified and re-mailed to those new addresses. Therefore, as of  
26 January 14, 2022, Gilardi has mailed a total of 84,922 Claim Packages to potential  
27 Class Members and nominees.



At the time of the Initial Mailing Declaration, Gilardi had not received any requests for exclusion from the Class at this mailing address. *See* Initial Mailing Declaration, ¶16.

6. Since the Initial Mailing Declaration was executed, and as of the date of this declaration, Gilardi has received two timely requests for exclusion, redacted copies of which are attached hereto as Exhibit A.

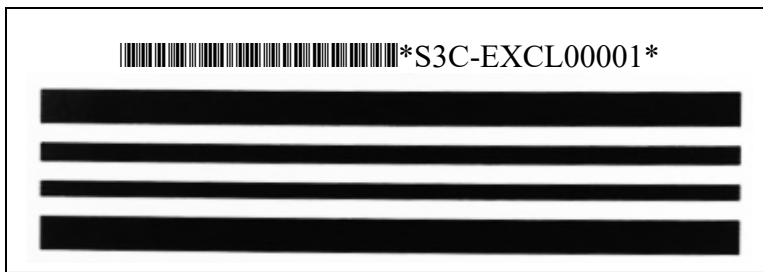
